All orders and sales are subject to these General Terms and Conditions of Sale, which

All orders and sales are subject to these General Lerms and Conditions of Sale, which the Buyer declares to accept in their entirely without reservation. These General Terms and Conditions of Sale prevail over any other document such as a catalogue, prospectus or the Buyer's terms and conditions of purchase. TOULEMONDE BOCHART reserves the right to modify its GTCS at any time. The General Terms and Conditions of Sale applicable shall be those in force on the date of the order placed by the Buyer.

#### 2. ORDER FORM

Orders may be placed either by sending an order form to TOULEMONDE BOCHART or by accepting a quotation from TOULEMONDE BOCHART. TOULEMONDE BOCHART. Toulemonde BOCHART reserves the right to refuse any order for any reason whatsoever, particularly in the event of a current or past dispute with the Buyer, suspicion of the Buyer's insolvency or unavailability of an ordered product.

#### 3. PRODUCTS

Sizes of rugs produced in all hand supports may vary by  $\pm$  5%. Colours may vary from one dye to another and may develop a patina over time. TOULEMONDE BOCHART reserves the right not to restock a reference shown in its catalogues and price lists, without this entitling the Buyer the right to make any claim against TOULEMONDE BOCHART.

#### 4. SELLING PRICE

Prices quoted are net prices in euros, exclusive of VAT and exclusive of delivery and/or installation costs, unless otherwise stated in the order confirmation. Prices are subject installation costs, unless otherwise state in the order contimitation. Process are subject to VAT at the rate in effect on the date of order confirmation by TOULEMONDE BOCHART, if applicable. In the case of sales within the European Union, the Buyer must provide their intra-community identification number, if applicable. Goods are invoiced based on the prices in effect on the day the order is placed, TOULEMONDE BOCHART reserves the right to modify its prices at any time. Any customs charges and other duties payable in the Buyer's country shall be borne by the Buyer alone.

#### 5. ACCOUNT OPENNING AND PRICE CONDITIONS

Before accepting a first order, TOULEMONDE BOCHART will open a customer account in the name of the Buyer and the latter will have to provide all information required by TOULEMONDE BOCHART to materialise their legal existence and their banking and financial situation (bank details, balance sheets, certificate of incorporation, Articles of Association etc.)

Association, etc.). The Buyer must then place an initial minimum installation order of at least 1,000 euros excluding VAT. This order will be shipped after payment on a pro forma basis. Customer accounts that have been inactive for at least 12 consecutive months will be automatically closed and the Buyer will lose any benefits that may have been granted, without TOULEMONDE BOCHART being held liable in any way whatscover. Any Buyer failing to achieve minimum annual sales of 2,000 euros excluding VAT will be closed the following year. The conditions of a new Buyer will then apply.

#### 6. PAYMENT TERMS

Approval of the order form by the Buyer is irrevocably binding. The company cannot be held responsible for any errors or omissions escaping the Buyer's attention at the time of approval of the order to be validated and the Buyer therefore assumes full responsibility. TOULEMONDE BOCHART makes every effort to ensure that the representation and specifications of the products shown on the purchase order are as faithful as possible to the actual products manufactured. ## 14. ACTS OF GOD AND FORCE MAJEURE

The creations and designs developed by TOULEMONDE BOCHART shall remain its exclusive property under all circumstances, and no transfer of intellectual property rights to the products, creations, designs, and brands shall occur as a result of an order placed by the Buyer. Under no circumstances shall the Buyer be authorised to reproduce or manufacture TOULEMONDE BOCHART products, creations, designs or trademarks, under penalty of legal action.

With respect to any order based on a design or fabric supplied by the Buyer, the Buyer warrants to TOULEMONDE BOCHART that it holds all intellectual property rights to the design in guestion or that such designs in guestion or that such designs in the signs i

warrants to I OULEMONUE BOUNERY I mat it notes all intellectual properly rights to the design in question, or that such design is in the public domain, and/or that the fabric supplied is not infringing and that it is the rightful owner thereof. In addition, the Buyer agrees to indemnify TOULEMONUE BOUNER against any claims by third parties and to bear all financial and legal consequences resulting from such claims, including reasonable attorneys fees, in the event of litigation in this regard. # 16. JURIDICTION AND APPLICABLE LAW

The Commercial Court of EVRY shall have sole jurisdiction to hear any dispute relating to the interpretation and execution of the GTCS, despite any clause to the contrary included in the documents produced by the Buyer, in their emails, on the purchase order or correspondence from the Buyer, and this, regardless of the place of delivery, the accepted method of payment and even in the event of a third party claim or multiple defendants. #### APPENDIX I - BUYER'S CODE OF CONDUCT
